A Powerful, Personal Story

During Christmas week of 1993, Chaplain Chéry's fifteen-year-old son, Louis, a brilliant student and a peacemaker, was murdered in the crossfire of a shootout. In the aftermath of this tragedy, she was without any support or information to guide her.

To honor Louis' legacy and to ensure that no other loved one would be left alone after the tragedy of homicide, Chaplain Chéry co-founded the Louis D. Brown Peace Institute (LDBPI).

Twenty-eight years later, the Louis D. Brown Peace Institute is an internationally recognized multi-million-dollar, multi-service agency serving thousands annually. It is a center of Healing, Teaching and Learning for families and communities impacted by murder, trauma, grief and loss.

Finding Purpose in Pain, A Mothers Journey

Chaplain Chéry invites everyone to join her in seeking peace. There is always more to be done. Chaplain Chéry's powerful, personal story resonates with everyone. Honoring Louis' memory and determined that no other family would be left unsupported after the murder of a loved one, Chéry moved through her pain. She found her calling through her faith and founded the Louis D. Brown Peace Institute to bring peace to her community and beyond. Chaplain Chéry knows personally how structural racism fosters violence in communities of color. Without shame or blame, she discloses this aspect of her journey and the LDBPI's responses to violence that counter this harmful narrative. She has realized her vision -- The Louis D. Brown Peace Institute exists today as a center of healing for all families traumatized by murder. As her journey unfolds, she shares how the LDBPI identified and created comprehensive, innovative resources, publications and services to address the unmet needs of survivors in respectful, culturally appropriate ways.

The Seven Principles of Peace

Audiences and participants are inspired, have new insights and tools to support their communities and their personal journeys to peace and justice.

Love, Unity, Faith, Hope, Courage, Justice and Forgiveness are LDBPI's seven principles of peace. They inform all the LDBPI's work and form the heart of healing trauma. Everyone who seeks peace, no matter if they have been impacted by murder or not, can bring these principles into their own lives. Chaplain Chéry's demonstrates how the power of each principle, and their collective power, transforms individuals and communities.

Driven By Faith, Called to Action

This presentation carries special meaning and motivation for all people.

After her son was murdered, Chaplain Clementina Chéry relied on her faith, prayer and bible study to lead her toward healing. For over two decades, Chaplain Chéry has worked through the LDBPI to fulfill her spiritual mission to help heal those impacted by homicide, whether their loved one has been killed or has been incarcerated for murder. Chaplain Chéry's calling is to do everything she can for all who need her love and guidance. The LDBPI and Chaplain Chéry call on God's divine wisdom, love and justice to help serve all who need them.



Looking ahead - Revolutionizing Philanthropy at the Grassroots

These are the wise words of Boston's late civil rights leader, Lenny Zakim, founder of The Lenny Zakim Fund, LZF. The Louis D. Brown Peace Institute was among LZF's first grantees. Lenny believed in Chaplain Chéry and before the LDBPI even knew what a grant was, LZF provided its very first funding. LZF also gave LDBPI the training, counseling, networking, and leadership opportunities essential to sustainability. Now, the LDBPI is paying LZF's gifts forward through its Inform, Influence and Impact grants for survivors. These grants empower survivors to create and execute a project that will be part of their loved ones legacy. Grantees receive training and experience in all aspects of grant seeking and reporting, just as Chaplain Chéry did from LZF. This is innovative, trust based, community driven funding with the power to revolutionize philanthropic thinking and practice for institutional and individual funders. Lenny said, "It doesn't take much to start a revolution of thought and spirit. It takes one person and then another. When it works, it's a work of art." LDBPI is carrying Lenny's vision and his revolution forward.

From My Kitchen Table to a Million Dollar Nonprofit Serving Thousands

This presentation tells the story of the Louis D. Brown Peace Institute's phenomenal organizational growth and is appropriate for nonprofit, civic and corporate audiences.

In 1994, in the aftermath of Louis' murder, Chaplain Chéry launched the LDBPI from her kitchen table. At the start, she had no experience, education, or training but she moved forward, gaining the skills and expertise she needed along the way. That was the beginning. Twenty-eight years later, the Louis D. Brown Peace Institute has grown from that tabletop into an internationally respected, multi-million dollar organization. Self-taught, Chéry is a strong, innovative, strategic leader and a skilled, and inspiring manager who provides support and pathways for growth and success to her growing team.



Who Was Louis D. Brown?

Louis D. Brown was a 15-year-old sophomore in the fall of 1993. He looked forward to college, and was planning to pursue a PhD. Louis was an avid reader and interested in engineering, he often mentioned to his family and friends his long-term goal to become the first black President of the United States. He often shared his commitment to making his community a more peaceful and just place. Alongside his peers, Louis worked to challenge the negative stereotypes about youth in his neighborhood. He was deeply concerned with the ongoing violence he and his peers experienced. Louis couldn't understand why adults were always blaming young people when bad things happen yet took the credit from young people when good things happened.

Louis was caught in a fatal crossfire shootout near his home in Dorchester, Massachusetts in December of 1993. His murder was high-profile. The media speculated about why a teenager was murdered in broad daylight. Was he in a gang? Was it a drug deal gone bad? When it was reported that Louis was, in fact, an honor student killed on his way to a Teens Against Gang Violence meeting, there was a major shift in public opinion. This shift in opinion led to an outpouring of support. But for Louis' family, this support raised an important question: what would the response to their family have been if he were in a gang or selling drugs? Would the media value his precious life? Would the same resources be poured in?

In his own words, "if true peace is to happen, it would be up to my generation, regardless which side of the street they are from." The Louis D. Brown Peace Institute is his living legacy.
